PRECAUTIONS

Recommended conditions for storage and processing: The processing features are strongly influenced by the storage conditions. Therefore we recommend that our films be stored at a relative humidity of 30 - 90 % and a storage temperature of +20°C / +/- 10° C. Storage time: 12 month from date of delivery in closed original container. Avoid exposure to UV-radiation.

The film reels should be acclimatized to room temperature at least 24 hours before processing. Extreme differences of temperature should be avoided. (i.e. avoid processing directly after delivery in cases of low outside temperature).
